- 1. This is to furnish all concerned a copy of DepEd Memorandum No. 17 s. 2021 and Regional Memorandum No. 114 s. 2021 both titled Designation of School Information Coordinators (SICs).
- 2. In this regard, all school heads (Elementary Schools, Junior High Schools and Senior High Schools) are tasked to designate a personnel who shall serve the counterpart of the Division and Regional Information Officers. The School Information Coordinators must be:
 - a. Holding a teaching or non-teaching position in the school;
 - b. At least two or three years employed in DepEd:
 - c. Able to communicate and write well, and have good public relations skills; and
 - d. Able to respond to issues and concerns requested by the schools division, regional and of the Central Office.
- 3. The designation of a teacher to perform as School Information Coordinator shall be recommended by the school head to the Schools Division Superintendent (SDS) for approval. Please use attached designation form.
- 4. Likewise, a District Information Coordinators (DICs) shall be recommended by the Public Schools District Supervisors.
