**TRAINING-WORKSHOP OF LEARNING RESOURCE EVALUATORS (LREs) ON THE

1. This Office, through the Curriculum Implementation Division (CID) shall conduct a Training-Workshop of Learning Resource Evaluators (LREs) on the Evaluation of Self-Learning Modules (SLMs) and other Learning Resources on June 15-17, 2021 via Google Meet.
2. This undertaking aims to capacitate the participants on the evaluation process of Self-Learning Modules (SLMs) and other learning resources.  
Specifically, the training-workshop aims to:
  - a. 2.1 equip the participants on the quality assurance / evaluation process of Self-Learning Modules (SLMs) based on guidelines; and
  - b. 2.2 apply the technical basis for evaluating quality learning resources for learners and instructional support for teachers.
3. The participants in this training are the Education Program Supervisors, Public Schools District Supervisors and the identified potential Learning Resource Evaluators (LREs) in each learning area (4 participants per learning area). The participants will serve as learning resource evaluators in addition to the pool of existing LREs. Participants are advised to secure a stable internet connection during the training.
4. No registration fee shall be collected; meals of the training team and training kits of the participants shall be charged against Division INSET funds subject to the usual accounting and auditing rules and regulations.
