## ENHANCEMENT OF CONTINGENCY PLAN FOR COVID-19

- 1. As part of the schools' continuing commitment to maintain a safe and child-friendly learning environment in schools, SDO Nueva Ecija will hold an activity that aims to calibrate and update the School's Contingency Plan for COVID-19 and make it more compliant with the current situation and vulnerability of the school. The enhancement in the Contingency Plan for COVID-19 is aligned with NDRRMC standard requirements and DRRMS prescribed templates. The said activity will be held on August 19, 2022 via Zoom Conferencing from 9:00am to 4:30pm.
- 2. The activity aims to equip the schools with responsive plans that will aid them in confronting emergency situations and ensure learning continuity in case of surge in COVID-19 cases.
- District DRRM Coordinators, District DRRM Presidents and eight (8) Secondary DRRM Coordinators from Cabiao NHS, NEHS, Talavera NHS, Bongabon NHS (both JHS and SHS) are required to attend the ZOOM Meeting. Link will be given through the Official Group Chat.
- 4. School Heads together with the School DRRM and Health Coordinators are enjoined to watch the Simultaneous FB Live Telecast via DRRM Official Facebook Group.
- 5. Prior year Contingency Plan are expected to be made available during Focal Group Discussions through the break out rooms. Presentation of output will be required in the afternoon to aid in the preparation of an enhanced contingency plan.
