## RESEARCH AND INNOVATION GUIDELINES ON THE SUBMISSION OF THE PROPOSALS AND COMPLETED PAPERS IN SDO NUEVA ECIJA

- 1. Relative to the Procedure Manual for QMS and ISO 9001 s. 2015, and the Division Memorandum No. 229, s. 2022 promoting the research culture and systematic workflow of the Research Unit, the three different paper proposals up to the final output such as the Action/Applied Research, Innovation, and Income-Generating Project must be given a deeper focus this FY 2023 by providing newly revised and updated guidelines in terms of its date of submission from the schools to the division office.
- 2. This division encourages everyone to have a copy of the newly revised and updated guidelines on the date of submission from the schools to the division office. The followings are the most essential parts of the 2023 Revised Guidelines for the Date of Submission of Both Proposals and Completed papers for Action/Applied Research, Innovation, and Income-Generating Projects:
  - 2.1. all paper proposals (Research, Innovations, and Income-Generating Projects) will only be submitted at the **end of the quarter** (last week of March, June, September, and December);
  - 2.2. all completed papers (Research, Innovations, and Income-Generating Projects) will only be submitted on a **semi-annual basis** (every last week of June and December); and
  - 2.3. all returned and complied paper proposals will be accommodated at the end of the month (last week of the month) after their initial technical and content evaluation until the issuance of the Certificate of Acceptance;
  - 2.4. furthermore, once the proponent was given the Certificate of Acceptance for their paper proposals, they will be given **only 6 months-12 months** (for Action/Applied/Basic Research) and **a minimum of 12 months** (Innovations and IGPs) to comply with the completion of their work.

TYPES OF PAPER	DATE
CALL FOR RESEARCH, INNOVATION, AND IGP PROPOSAL	Every last week of the Quarter of the given FY (March, June, September, and December)
RESEARCH, INNOVATION, AND INCOME-GENERATING PROJECT COMPLETED	Semi-annual basis (every last week of the month of June and December)
MONITORING OF SUBMITTED PAPERS	January-February, April- May, July- August, October- November
